2. All officers and members have approved this fundraiser and at least one signatures for our organization / group / team has been provided. We are ready to reserve our HomeScent Ultimate Fundraiser dates and start selling!
3. I have provided the *Start and Finish Dates* above and agree to have the *Master Wholesale Order Form* returned within 7 business days from the provided *Finish Date*. Should my organization decide to change these dates I agree to notify HomeScent for the new Start Date approval. This contract will not be honored by HomeScent, LLC after 60 days.
4. I agree to send full wholesale payment along with the *Master Wholesale Order Form*. When making payment, I understand that HomeScent, LLC accepts cash(local only, do not mail cash), money orders, or organization/ company checks. *No personal checks will be accepted from sellers or purchasers*. I also agree to reimburse HomeScent, LLC in the event of a returned check plus a \$25.00 fee will be applied.
5. A minimum of 96 candles must be sold per fundraiser to receive free shipping/delivery. Orders less than 48 candles will be subject to a \$10.00 small order fee. HomeScent Ultimate Fundraiser soy wax candles sell for \$12.75 retail. Your wholesale cost is \$6.75, earning your organization \$6.00 per candle sold.
6. Notification of any damaged or missing orders shall be made within 10 days of the date you receive order.
7. All orders will be shipped within 14 to 21 business days from the date of payment and order placement. Orders paid by organization/company check will not ship before check has cleared the banking system.
